In pursuance of the orders issued by the Government under reference 1<sup>st</sup> to 4<sup>th</sup> cited read above and as per the option exercised by the individuals through web counselling vide reference 5<sup>th</sup> cited. The School Assistant's and equivalent cadres as shown in Annexure are hereby transferred and posted to the new stations which are approved by the District Level Committee.

The Headmasters concerned are requested to relieve the School Assistants who are transferred immediately with instructions to report at new station. The Headmasters concerned should report the date of relieving and joining of the incumbent promptly to the undersigned.

However, the Headmasters are instructed to ensure that the teachers who are considered for transfers shall be continued in the same post and school, until another regular teacher joins in that school, unless minimum requirement of teacher strength as per rationalization norms is fulfilled. In case, if the minimum requirement is met as per rationalization norms, only the senior most teacher/s shall be relieved.

He / She shall abide by the terms and conditions as stipulated by the Government and are liable for any action deemed fit for violation of orders if any.

The Headmasters concerned are requested to take necessary entries in the Service Register of the individual regarding the transfer/Date of relieving/Date of joining and availment of Special Category/ Preferential Category if utilized by the individual.

These orders are issued subject to outcome of final orders in W.P.No 3962 of 2023 and batch cases pending before the Hon'ble High Court.
