In case, if the minimum requirement is met as per rationalization norms, only the senior most teacher/s shall be relieved.

He / She shall abide by the terms and conditions as stipulated by the Government and are liable for any action deemed fit for violation of orders if any.

The Headmasters concerned are requested to take necessary entries in the Service Register of the individual regarding the transfer/Date of relieving/Date of joining and availment of Special Category/ Preferential Category if utilized by the individual.

These orders are issued subject to outcome of final orders in W.P.No 3962 of 2023 and batch cases pending before the Hon'ble High Court.
